ADVOCACY HIGHLIGHTS

SCANPH continued advocating for policies and regulatory reforms that align with our mission of expanding the development of affordable housing to assist those who are most affected by the housing and homelessness crisis in our communities.

VICTORIES FOR STREAMLINING AFFORDABLE HOUSING PRODUCTION!

SCANPH staff has been collaborating with Los Angeles city councilmembers and staff since 2021 on policies to increase the production of affordable housing. In 2023, the City Council passed two influential streamlining motions that SCANPH membership and staff helped to conceptualize.

- Executive Directive 1 (ED 1): expedites the processing of shelters & 100% affordable housing projects receive in Los Angeles
- Site Plan Review Ordinance Amendment: exempts all affordable units from Site Plan Review process

SB 4 SIGNED INTO LAW!

Since 2020, SCANPH has been working on the passage of SB 4, or the Affordable Housing on Faith Lands Act in California. This bill was signed into law in 2023, allowing for religious organizations and nonprofit colleges to develop affordable housing on their property under a streamlined process. Thank you to our members, partners, and fellow co-sponsors on getting this important legislation passed!

SCANPH CONSULTING DIVISION

Our consulting team seeks to build local government capacity to foster programs and policies that make it easier to build affordable housing throughout the region. In 2023, SCANPH's consulting division worked with SCAG to coordinate \$19 million in State REAP funding. This funding was used to streamline housing development approval processes, and in significant activities and projects that augmented local housing planning. Additionally, through SCANPH's second contract with SCAG, our consultants provided grant-writing technical assistance to two cities, three counties, and five councils of government throughout the region.




