### ADVOCACY HIGHLIGHTS

**SCANPH** continued to fight for policies and regulatory changes that support our mission of expanding affordable housing development to help those most impacted by the housing and homelessness crises.



\$30 mil in ARPA funds in w/ Ventura Housing Coalition. Measure ULA. Lobbied against 41.18



State Level: Wrote letters in support for 15 statewide bills. Sponsored SB 1336.

Successfully lobbied for readiness deadline extensions at both TCAC and CDLAC due to dramatic cost increases



**Federal**: Outreached to 10 offices regarding the Affordable Housing Tax Credit Improvement Act + the Housing for All Act

#### **HARNESSING THE EXPERTISE OF SCANPH MEMBERS:**

SCANPH members once again acted as an incredible resource for thought leadership in 2022.

This year, we brought back the Housing for Stronger LA group - a cohort of LA developers focused on city hall engagement and LA development hurdles. The group met 8 times this last year and helped plan our LA City Mayor's Candidate Forum!

#### **SCANPH CONSULTING DIVISION**

SCANPH's consulting division was contracted by SCAG to implement the REAP Program, which is state funding provided to accelerate housing production and facilitate compliance in implementing the 6th cycle RHNA. SCANPH oversees significant activities and projects that augment local housing planning, and also provides technical assistance to jurisdictions/grantee partners of this funding.

Under a second contract with SCAG, SCANPH provides technical assistance to SCAG jurisdictions seeking housing-supportive grants and related applications.


